On 17 May 2016, the Company granted 56,760,000 share options under the share option scheme adopted on 1 November 2011 to certain eligible persons (including the Directors, substantial shareholder and consultant of the Company) (collectively, the “Grantees”) to subscribe, in aggregate, for up to 56,760,000 ordinary shares of HK\$0.01 each in the share capital of the Company at HK\$0.189 per share during the period from 17 May 2016 to 16 May 2026. 2. On 13 May 2016, the placing agent and the Company entered into the placing agreement pursuant to which the Company has conditionally agreed to place through the placing agent, on a best effort basis, up to 420,000,000 placing shares at the placing price of HK\$0.15 per placing share to not less than six placees who and whose beneficial owners shall be independent third parties. On 25 May 2016, 420,000,000 placing shares have been issued to independent third parties in accordance with the terms of placing agreement dated and announced on 13 May 2016.
